



### **Terms and Conditions of Entry**

1. The Art Sale and Auction is run as part of the Annual Rainbow Dinner (the Event), which is a fundraising event organised by the Rainbow Communities Tasmania Inc.
2. Entry is open to ALL people 18 years of age and older who reside in Australia. Please complete and return the attached Official Entry Form (the Form) as soon as practicable but no later than Sunday 28 October 2012.
3. Media allowed: drawing, painting, sculpture, photography, assemblage, ceramics, jewelry and mixed media.
4. Any one Artist may enter no more than three individual works. Each entered artwork is to be the original work of the Artist. Due to space limitations not all entered artworks may be accepted and or displayed. Artists with multiple entries are asked to nominate their order of preference on the Form.
5. The Artist on delivery of the artwork must present all artworks entered ready for display. Drawings, paintings, photography and mixed media must be mounted and preferably framed and have D rings attached ready for hanging. Wet artwork cannot be accepted.
6. The Rainbow Dinner Committee (the Committee) reserves the right of selection of artwork to be accepted for and displayed at the Event and designation of the method of sale. The methods of sale are Direct Sale and Auction. The Committee's decision will be final and no discussion or correspondence can be entered into regarding the Committee's decisions.
7. The Artist shall make the selected artwork available for inspection by the Committee or the Committee's representatives upon request.
8. The Artist will be advised of the Committee's decision relating the selection of artworks to be displayed at the Event and designation of the method of sale seven days prior to the Event.
9. The Artist will receive a fee representing thirty per cent of the final sale price for each entry sold (the Fee). The Fee is non-negotiable and the Committee will not enter into any discussions or correspondence regarding alternative arrangements. Artists wishing to donate their Fee may indicate this on the Form. Rainbow Communities Tasmania Inc is a charitable organisation and donations over \$2 are tax deductible.
10. The Artist shall provide a digital photograph of each entry and a brief Artist's Statement describing each entry by the date indicated on the Form. Late entries will not be accepted and may result in the artwork being withdrawn from the Event.
11. The Artist must allow photographs of each submitted work and the Artist's Statements to be used in promotional materials for the Event and future events organised by the Rainbow Communities Tasmania Inc or any of its affiliates.
12. The Committee will advise the Artist of arrangements for delivering the artwork to the Event and collecting unsold artwork or artwork for which no payment was received within the designated time.
13. Although all reasonable care will be taken, the Committee, the Rainbow Communities Tasmania Inc and its affiliates accept no liability for damage to or loss of the artwork during transportation and display at the Event. Insurance is the responsibility of the Artist.
14. The Fee will be paid to the Artist's nominated bank account within seven days from the day of the payment by the buyer. The Committee will take all reasonable steps to ensure that buyers pay the displayed price or the highest bid within seven days from the day of the Event.
